# Focus on What Matters

Burneikis, who handles primarily personal injury cases related to roadway incidents, along with other complex accident cases, said Transcript Genius allows her to save time in many different ways:

## 1. Summarize Quickly

Transcripts are summarized in minutes, a job that once took hours. "Before Transcript Genius, it was just reading through the deposition and creating a summary. You'd have a chart with page line numbers on the left side and the summary of the testimony on the right," Burneikis explained. Now, she can generate customized summaries instantly.

## 2. Find Contradictions

Contradictory testimony can be easily identified, another task that often took hours. "It's amazing because in my own mind, when I'm taking a deposition, I'll think, 'Well, that's not what they said earlier.' Now you really can go back and say, 'Well, here it is. Here they said X, and here they said Y.'"

### 3. Get Instant Answers

Key passages in any transcript can be located quickly during a deposition. "Before, you'd have to, on the fly during trial, scan through papers as you're flipping through, to find the testimony you were looking for. Sometimes you know it has to be very fast because the judge is waiting on you."

### 4. Compare Multiple Transcripts

In cases with numerous witnesses, Transcript Genius allows for efficient comparison across testimonies. "In this case, it was nine depositions... I didn't want to have to go through and read through nine depositions before I took the next depo, just where they talked about a specific topic."

### 5. Quantifiable Time Savings

While exact time savings can vary by case, Burneikis estimates that Transcript Genius saves her hours on each case. "I would say hours. I mean hours we're saving," she noted.
